POLICY & ADVOCACY

This past year brought significant challenges for business growth and resilience: persistent inflation, affordability concerns, labor disruptions, complex policy shifts and global geopolitical changes. Through these challenges, 2024 showcased the power and importance of thoughtful policy, consistent advocacy and strong communications.

This year, we proudly championed our members — from small businesses to multinationals across energy, agriculture, retail, tech, and tourism — advocating for practical solutions to empower Calgary’s business community and drive shared prosperity.

POLICY HIGHLIGHTS

We focused on actionable, non-partisan and member-driven solutions to address critical challenges such as affordability, uncertainty around the incoming U.S. administration and trade, regulatory complexity and more.

Signature Reports

Go Big Business on Small Business: Recommendations to support small business success (October 2024)

With over 167,000 small business in Alberta, their success is crucial to the vibrancy and growth of the province. This report outlined recommendations for all levels of government to support small business.

2024 U.S. Election: Strengthening Canada’s economic future (September 2024)

Canada and the U.S. have one of the largest trading relationships in the world, and the incoming Administration has major implications for Canadians. This three-part series dove into the bilateral relationship, the economic impacts of U.S. policy on Canada, and how Canadian governments should respond.

Rural Connectivity: Unlocking the Alberta advantage for everyone (September 2024)

Given how critical connectivity is for economic participation, this report shed light on the fact that most people living in rural, remote and Indigenous communities in Alberta lack access to reliable broadband service and contained recommendations for all levels of government to address this connectivity gap.

Home Economics: Unlocking growth through housing solutions (June 2024)

As Calgary’s population has skyrocketed, this report raised concern over waning housing affordability in Calgary and offered recommendations to all levels of government to address the housing crisis and curb the pace at which house prices are rising, including by supporting talent and labour, and streamlining regulatory processes for the construction industry.

ADVOCACY HIGHLIGHTS

The Chamber deepened its advocacy efforts and influence this year, convening the business community to hear their concerns, push for policy change, ensure that their voice is heard by decision-makers at all levels and raise awareness of policy decisions with the public.

Energy & Environmental Policy

- Called for the withdrawal of the proposed *Oil and Gas Emissions Cap, Clean Electricity Regulations, and Competition Act* amendments, advocating instead for investment in decarbonization technologies and collaborative initiatives to attract investment.
- Pushed for affordable, reliable and available electricity while addressing the economic impact of punitive regulations on businesses.

Labour Disruptions & Talent

- Highlighted the economic consequences of rail, port and postal strikes on supply chains and small businesses.
- Advocated for policies to address labor shortages and attract talent to support business growth.

Tax Fairness

- Urged the provincial government to eliminate the 2% small business tax and called for increased access to capital for small businesses.
- Advocated for property tax competitiveness to ease affordability pressures for businesses.

Budgets & Economic Policy

- Published quarterly assessments of business optimism and challenges to inform policymakers.
- Ensured business priorities were central to public budgets at all levels of government.

Housing & Infrastructure

- Advocated for increased homebuilding in Calgary to address housing affordability.
- Emphasized the need for stable infrastructure investments, including housing, transit and education, to support Calgary’s population growth.
- Recommended investments in infrastructure and other key initiatives to support public and business safety.
- Supported strategic initiatives to develop arts, sports and culture infrastructure in Calgary.

Geopolitical Trends

- Analyzed the impact of the U.S. election on Canada, including proposed tariffs and trade relations, providing recommendations for government action.

POLICY & ADVOCACY WINS

The Chamber influenced policy on key files from property tax and investment tax credits to regulatory policy and housing to safety and tourism. Notable decisions influenced include:

- City Council voted to maintain the property tax shift in its mid-cycle budget adjustments, avoiding increased costs to businesses.
- The passing of investment tax credits and Canada Growth funding to support investments in CCUS, hydrogen, clean electricity, geothermal and more.
- *Clean Electricity Regulation's* "What We Heard" report implemented feedback shared by the Calgary Chamber to ensure electricity reliability and affordability.
- The announcement of Calgary funding from the federal Housing Accelerator Fund and the passing of the Calgary Housing Strategy with amendments to reduce red tape for the development of housing.
- Changes to the Local Access Fee legislation to support lower utility costs in Calgary.
- Alberta Carbon Capture Incentive Program passed in Budget 2024, in addition to investments through Emissions Reductions Alberta, to support the development of decarbonization technologies.
- Downtown Safety Leadership Table's recommendations were approved and adopted into an implementation plan.
- Tourism and Hospitality Immigration Stream announced, with potential to add other streams, including for the construction industry.



GROWING OUR COMMUNITY

INCLUSION, DIVERSITY, EQUITY AND ACCESSIBILITY

We are *Better Together*, and in this spirit, are committed to fostering an inclusive community that promotes equity, advances accessibility and celebrates diversity.

Our cross-departmental Staff Working Group is integrating an inclusion lens into our work, strengthening relationships within diverse communities and developing a formalized Inclusion, Diversity, Equity and Accessibility (IDEA) strategy, which includes (1) updating our internal culture and processes, (2) connecting members with resources, and (3) advocating for an inclusive economy.

Highlights

- Our hiring and employment practices have been updated to ensure the Calgary Chamber is an inclusive and welcoming place to work.
- Our events are consistently held at accessible venues, and across the city, meeting our business community where they are. We strive to showcase panelists who reflect the diverse backgrounds and experiences of our business community.
- We hosted our annual Mental Health Forum and Inclusion, Diversity, Equity and Accessibility Forum, sharing how prioritizing these improves business outcomes.
- We share IDEA resources on our website, supporting our members as they advance inclusion in their own businesses.
- Our team shows up for our communities everyday—and for big events like the Pride Parade, Axis Connects Gala and the Calgary Black Achievement Awards.
- We celebrate and amplify the exemplary work of leaders integrating IDEA into their businesses, including through our IDEA Small Business Week Award.

TRUTH & ECONOMIC RECONCILIATION

All of us have a role in advancing Truth and Reconciliation. Call to Action #92 calls on Canada's corporate sector and business community to advance reconciliation, and we are humbly learning and expanding our work.

As an organization and led by our cross-departmental Staff Working Group, we are committed to advancing reconciliation through economic opportunity. Informed by engagement with Indigenous professionals and entrepreneurs, we are actively working to support Indigenous entrepreneurs and professionals, amplify Indigenous voices, celebrate achievements and progress, and advocate for systemic change.

Highlights

- We consulted over 25 Indigenous entrepreneurs and community members in the development of our Truth and Economic Reconciliation Framework, which will guide our work in 2025 and 2026.
- The Chamber hosted our annual National Indigenous Peoples Day Forum and panel event, *Empowering Indigenous Entrepreneurs: Strategies for supporting small business success*.
- We reintroduced the Indigenous Entrepreneurship Award as part of our Small Business Week Awards Gala, highlighting exemplary Indigenous entrepreneurs with a commitment to community.
- With systemic barriers continuing to impede Indigenous entrepreneurs, the Chamber is advocating on policy issues related to procurement, access to capital, tax and rural connectivity.

EVENTS

From annual events like Chamber Fest and the Chamber Charity Classic to our signature series including Business After Hours and Confluence YYC, these events brought together businesses and individuals from more than 20 industries to connect, collaborate and celebrate our local business community.



EVENT HIGHLIGHTS

This year, the Calgary Chamber re-introduced the Stampede Party, a signature event we revived from Chambers past, designed to celebrate the *Greatest Outdoor Show on Earth* in style. Bringing together business leaders, community builders, government representatives and stakeholders from across the country, the event offered attendees a chance to experience the Stampede with live country music, delicious food, networking opportunities and exciting games. Held at the Calgary Marriott Downtown Rooftop, our party welcomed more than **400 guests** against a backdrop of picturesque downtown views.

Alberta Next focuses on key sectors: agribusiness, energy and environment, and transportation and logistics. It hosts important conversations with thought leaders, government and industry experts about Alberta’s role in driving innovation and attracting investment in these industries. With a keynote address and two expert panels, the Alberta Next series engaged nearly **450 attendees** to discuss the most pressing challenges facing the business community and provincial economy.

Chamber Fest, the Calgary Chamber’s annual celebration of the local business community, was a free-for-members event held in the lobby of the Ampersand. As one of our most highly attended events, we welcomed more than **600 attendees** to Chamber Fest this year. With engaging partner activations, delicious food and fun games, this year’s Canadiana-themed Chamber Fest brought everyone together to enjoy iconic Canadian culinary delights and Canadian music.

The Chamber Charity Classic golf tournament was a tremendous success again this year, welcoming more than **150 golfers** to a sunny day on the links at Bearspaw Golf Club. With 50 silent auction prizes donated from various partners and a \$10,000 donation gifted to Wood’s Homes, 2024’s edition of this annual event made a real impact, supporting our community and helping to build fruitful connections.

Small Business Week, presented by our Small Business Pillar Partner Rogers Business, was our annual week-long celebration dedicated to Calgary’s small- and medium-sized businesses, which make up over 95 per cent of our city’s business community. From the Business After Hours Kickoff at TELUS Spark with Ro5ie the Robo Coaster to a panel about turning failure into a springboard for success, a discussion on supporting Indigenous entrepreneurs and the much-anticipated Small Business Week Gala, Small Business Week collectively welcomed nearly **600 attendees** to network, learn and celebrate with the Calgary small business community.

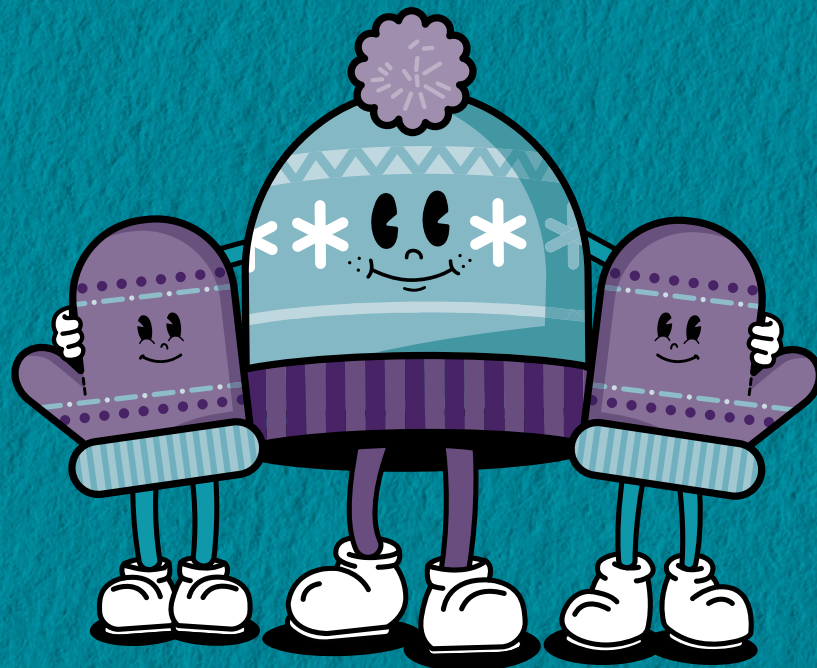
